**Commissioners Regulation (CR) 100.7: Age Eligibility for HSE Testing**

Regulation Citation	Requirement	Acceptable Institutions Attesting to Age Eligibility and Authorized to Sign the Age Eligibility Form
CR 100.7(a)(1)(i) shall be <b>19</b> years of age or over, <b>or 18</b> years of age or older in the case of a student receiving a high school equivalency diploma based on successful completion of the <b>National External Diploma Program</b> ; <b>or</b>		
(ii) shall be <b>at least 17 years of age, and:</b>	(a) has not attended a regular, full-time high school program of instruction within the preceding 12 months; <b>or</b>	Last high school attended
	(b) shall be a member of a high school who has graduated; <b>or</b>	Last high school attended
	(c) has been accepted into the U.S. Armed Forces; <b>or</b>	Specific branch of Armed Forces
	(d) has been accepted into college or post-secondary institution; <b>or</b>	College or post-secondary institution including vocational training programs
	(e) is a resident of a narcotic addiction control center, a rehabilitation facility, county jail, prison, detention center or hospital, or is an adjudicated youth under the direction of a court or a parole, probation or other law enforcement agency and the head of such institution, the court, or the parole officer or probation officer having oversight over such individual, as applicable, certifies that the high school equivalency diploma constitutes an essential element of the rehabilitation program; <b>or</b>	Qualified program attesting to enrollment

	(f) is enrolled in an alternative high school equivalency preparation program in accordance with subdivision (h) of this section; <b>or</b>	Alternative High School Equivalency Preparation Program (AHSEPP) Coordinator
	(g) is home-schooled pursuant to section 100.10 of this Part; <b>or</b>	School district where the student is registered as a home-school student. (Parent or private home-schooling programs may not attest to age eligibility.)
	((h) is foreign born and never attended K-12 schools in the United States;	A parent may attest with the signature of a notary public. Test takers must register and affix the Age Eligibility form with a GED ID. The verification section of the Age Eligibility form may need to be left blank.
(iii) shall be <b>at least 16 years of age</b> and has reached maximum compulsory school attendance age; <b>and</b>	(a) has been accepted into the U.S. Armed Forces; <b>or</b>	
	(b) has been accepted into college or post-secondary institution; <b>or</b>	
	(c) is enrolled in an alternative high school equivalency preparation program in accordance with subdivision (h) of this section; <b>or</b>	
	(d) is home schooled pursuant to section 100.10 of this Part
